We know that last year was difficult for families with kids home for distance learning. 



Since 2008 more than \$951,000 has been distributed to the San Carlos School District and San Carlos Charter from the SCEF endowment fund. As of June 30, 2021 the balance in the endowment fund was \$3,215,539. No distribution was taken from the endowment fund in fiscal year 2021. Our audited financial statement for the year ended June 2020 is available on our website www.scefkids.org. Fiscal Year 2020-21 numbers presented here are for information purposes. Once our audit for fiscal year 2020-21 is complete, it will be posted to our website. Our Foundation manages our operations using a net proceeds model, in which we view revenues net of direct expenses. As such, costs for our annual auction gala and other events are deducted from the associated revenues. Therefore, revenues and costs under US Generally Accepted Accounting Principles will differ from those presented herein.

*In FY21, SCEF entered into a one-year agreement with San Carlos Charter (SCC) to pilot a joint ask campaign wherein SCEF collected funds on behalf of the SCC Fundraising Association to replace school donations usually generated by their annual Chili Cook-Off. These donations were then granted directly to SCC.

Librarians & STEMscopes

SCEF is supplementing Federal Cares Act funding to reopen school libraries. Additionally, our Fund-the-Future campaign is providing dollars to assist with the launch of the new Next Generation Science Curriculum (NGSS) so that teachers receive professional development and every student has access to hands-on science supplies and materials.



Music Programs & Other Middle School Electives

Our dedication to supporting a whole-child education continues this year. Our grants help fund middle school electives including computer science, Spanish, art, design, band and orchestra, while younger students benefit from the Music for Minors program. This year a new instrument replacement program is being initiated to ensure students have the tools they need for their music education.



Smaller (K-3) Class Sizes

San Carlos class sizes in elementary school continue to be smaller than the state average as our grant enables the district to hire additional teachers, lowering the teacher-to-student ratio. This allows teachers to provide more personalized instruction to our youngest learners.

Principal Flex Funds

Each school receives a grant for site-specific needs. This year principals are using these funds to purchase Diversity, Equity, Inclusion books and books for leveled libraries, tents for outdoor learning, learning applications/subscriptions, classroom technology including Chromebooks, voice amplifiers, active boards, and miscellaneous supplies and equipment.



Mental Health & Social/Emotional Program Support

The social-emotional development of children is fundamental to their ability to succeed at school. Each year SCEF provides funds to augment the team of counselors and behavior techs at our schools.



Technology Staff, Devices & Online Learning Apps

SCEF funds Technology Associates to manage technology infrastructure, continue to fund online learning applications, and the replacement of outdated Chromebooks and iPads for students.



Educator Innovation Fund (EIF)

EIF grants enable teachers to put design thinking to work testing dynamic classroom projects in areas such as literacy, science, technology, engineering and math. Often these projects scale to become widely adopted across schools and grade levels.

Read-A-Thon Success!

SCEF volunteers and staff organized a new Read-A-Thon and gained support from the San Mateo County Library and San Carlos's Independent bookstore, The Reading Bug. Community members and students recorded video Tributes recommending their favorite books. More than 1,600 students participated in the inaugural Read-A-Thon, logging more than 415,000 minutes of reading on the online Minutes Tracker.



In addition to its multi-year commitment to SCEF, **Alexandria Real Estate Equities** made an extraordinary donation to both the school district and SCEF in response to the pandemic.


